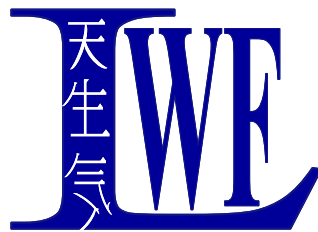

LWF Reiki Courses

Students are taught by traditional methods however the LWF is the only Reiki training provider in the UK that has been accredited by the Scottish Qualifications Authority. We are the only Reiki organisation who has this qualification. You will be given instruction in other aspects that will help you to deepen and develop your understanding of the healing principles. This will give you a strong foundation on which you can build, should you wish to study other complimentary therapies, implement the knowledge you have gained to your existing profession, or develop your own therapy business. At the end of each course you will be presented with the appropriate Reiki Manual.

1st Degree Course SCQF level 6 and 5 credits (Higher equivalent) Cost £125

1st Degree Reiki is the probationary level and confidence and experience can only be developed by practice and serious application. 1st Degree is primarily for "the self". During this course you will receive four Attunements which will provide you with the ability to perform Reiki on yourself and practice on others during your probationary period of study. You may decide that you only wish to participate in the first level and this is acceptable.

2nd Degree Course SCQF level 7 and 5 credits (Advanced Higher equivalent) Cost £200

2nd Degree Reiki level is known as the practitioner level and this level empowers you and teaches you the sight, sound, and understanding of the Reiki Symbols that are used in the 1st Degree course. This is an entirely different learning experience and you will be required to memorise the names and sounds of the three first degree symbols. This course also teaches aspects of running your own business or implementing your new found knowledge in a complementary therapy field. Although this course is fairly intense it is also a very enjoyable experience. At the end of the course you will be presented with your 2nd Degree course manual and once the case studies and completed assessment have been evaluated Diplomas are issued. You are then qualified to begin working with clients on a professional level.

3rd Degree /Master SCQF level 8 and 7 credits (HND equivalent) Cost £300

3rd Degree, Master level Reiki course observes the same strict handed down procedures as the first two courses and although additional learning is required this course is more spiritual than the 2nd degree course. You are given sight sound and understanding of the symbols used during the second degree course and you will be required to memorise them. You will also be taught how to perform healing Attunements as part of the healing process in cases of serious, chronic, or terminal illness.

These Attunements are generally performed on carers of the chronically or terminally ill so that they can provide healing sessions as and when the patients require them, rather than waiting for the availability of a master practitioner. This is not license to teach Reiki. Reiki can only be taught once the student has completed a teacher training course.

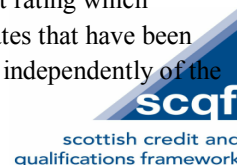
Masters who have been trained elsewhere (includes revision) Cost £600

On completion of the Master Teacher Course the new Master Teacher is fully qualified to begin to run training courses and this can be done independently or under the umbrella of the LWF.

Masters trained elsewhere would be required to sit an assessment and based on the results, appropriate additional training would be provided to achieve SCQF standards.

Teaching Independently

Should you wish to teach independently you will be required to produce your own manuals, certificates, and advertising media such as brochures or business cards. You may use the statement Trained by The Lightworkers Foundation but any certificates that you issue will not have the SCQF Credit rating which belongs solely to the LWF and can only be issued by us based on test papers and certificates that have been provided by us. The SCQF Logo cannot be used if the new master teacher begins to work independently of the LWF

Therapy Insurance

Insurance is highly recommended on all LWF Reiki Courses and should be purchased as soon as possible unless you already have current insurance.

Registration

A registration form is enclosed and this should be completed and returned with your preferred date and course location, i.e. Dunoon, Glasgow or Lochaber.

Master Teacher courses are a serious undertaking and registrations will only be issued after consultation between the applicant and the LWF Teaching Masters to ensure that the applicant is fully aware of the associated responsibilities.

Reiki Diplomas

Diplomas are only issued once all paperwork has been completed, submitted, and evaluated. When this process is completed you will be issued with your Diploma. Should you choose to be registered with the SCMA and you will receive a Reiki Certificate from the SCMA.

SCQF

Traditionally all Reiki teaching Masters have issued an "in house" Certificate or Diploma. The LWF has achieved ratification by the Scottish Qualifications Authority and is the only Reiki Training Provider who can issue industry recognised SCQF Diplomas.

1st degree Reiki SCQF level 6 and 5 credits (Higher equivalent)

2nd degree Reiki SCQF level 7 and 5 credits (Advanced Higher equivalent)

3rd degree Reiki SCQF level 8 and 7 credits (HND equivalent)

Master Teacher Degree Reiki SCQF Level 9 and 27 Credits (Graduate equivalent)

Master Teacher Soraya spent two years working with individuals recovering from addictions to a variety of substances. Initially when the courses first began it was anticipated that there would be a “drop out” rate of about 80% however the LWF achieved 100% attendance and extra students were accommodated. A high success rate was achieved with participants going on to attain positions in voluntary placements within the community, finding employed positions, and even setting up in their own business.

The LWF has trained 6 Reiki Master Teachers and 4 Reiki Masters and several hundred practitioners at 1st & 2nd Degree. These practitioners have direct lineage to

LWF Code of Conduct

As a member of The Lightworkers Foundation you are expected to adhere to our Code of Conduct as listed below. Failure to adhere to the principles, as set out will result in exclusion from the Foundation

1. At Advanced 1st degree level you must have and maintain appropriate insurance and may only practice Reiki on your self, members of your family and those within your close circle of friends until your Diploma has been received.
2. At Advanced 2nd Degree level you must have and maintain appropriate insurance in order to practice on others, whether you do so for free or with charges.
3. At Advanced 3rd Degree Level you must be aware that your actions are an example for others to follow therefore you must maintain the highest standards of attitude and demeanour. You must have and maintain appropriate insurance
4. At all levels, you should keep an accurate record of all client consultations and practice sessions. This will help you to gain valuable experience and in the event that a complaint is made these records are required by law
5. You must observe client confidentiality.
6. You must not exploit a client financially, sexually, emotionally or in any other manner.
7. You must not disparage other professional disciplines or act in a manner which would bring disgrace to the Foundation.
8. You must report any complaint against you or any incident or suspicion of malpractice by another member immediately to Master Teacher Soraya on (h) 01369 830029 (d) 01369 706424
9. You are requested to offer support if asked to another member of the foundation or pass that request within the foundation to someone who can assist.

The LWF Aims and Objectives are to :-

- Provide a strong foundation for the student to develop further training in other complimentary therapies
